

**RESOLUTION NO. 17-5366**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA PUENTE, CALIFORNIA, RESCINDING RESOLUTION NO. 17-5359, AND AMENDING THE COMPREHENSIVE PERSONNEL SYSTEM AND ESTABLISHING THE NUMBER OF AUTHORIZED FULL-TIME POSITIONS AND MONTHLY SALARY RANGES FOR CITY EMPLOYEES**

**WHEREAS**, the City Council wishes to rescind Resolution 17-5359 to establish the number of authorized full-time positions and monthly salary ranges for City employees for the 2017-2018 fiscal year, effective July 1, 2017.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA PUENTE HEREBY FINDS, DETERMINES AND RESOLVES AS FOLLOWS:**

SECTION 1. Effective July 1, 2017, Resolution 17-5359 is hereby rescinded.

SECTION 2. The salary ranges and position titles of Unclassified Exempt, Exempt At-Will, Classified Exempt authorized positions are as follows:


