

RESOLUTION NO. 15-5251

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA PUENTE, CALIFORNIA, AMENDING THE COMPREHENSIVE PERSONNEL SYSTEM AND ESTABLISHING THE NUMBER OF AUTHORIZED PART-TIME POSITIONS AND HOURLY RATES FOR CITY EMPLOYEES

WHEREAS, the City Council wishes to establish the number of authorized part-time positions and hourly rates for City employees for the 2015-2016 fiscal year, effective January 1, 2016.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA PUENTE HEREBY FINDS, DETERMINES AND RESOLVES AS FOLLOWS:

SECTION 1. The hourly rates and position titles of Classified Part-Time, non-exempt authorized positions are as follows:

A. Classified Positions (Part-Time) Non-Exempt	Authorized Positions	Hourly Rates Steps A - E
Management Intern	1	10.00 – 12.16
Recreation Leader	25	10.00 – 12.16
Recreation Specialist	10	11.04 – 13.42
Maintenance Assistant	2	15.20 – 18.48
Maintenance Worker	1	16.37 – 19.90

SECTION 2. The hourly rates and position titles of Contract Part-Time, non-exempt authorized positions are as follows:

B. Contract Positions (Part-Time) Non-Exempt	Authorized Positions	Hourly Rates Step A - E
Code Enforcement Officer	8	13.30 – 16.17
Code Enforcement Parking Control	2	13.30 – 16.17
Community Service Officer	2	20.00

SECTION 3. The hourly rates and position titles of Temporary Part-Time, non-exempt authorized positions are as follows:


C. Temporary Positions (Part-Time) Non-Exempt	Authorized Positions	Hourly Rate Step A - E
Deputy City Clerk	1	20.94 – 25.45
