Senior Sewer Discount Program Property Tax Year 2017-18

OVERVIEW

1. City Council Approved Discount "Sewer Charge Ordinance" (Ordinance No. 06-850) in 2006.
2. Who qualifies?
 - a. Property Owners 62 years of age and older as of May 1, 2017.
 - b. Income guidelines based on U.S. Department of Housing & Urban Development pursuant to section 4.10.070 of the City's municipal code (see below).
 - c. Water usage of less than 200 gallons per day (City Staff will verify. Please submit copy of water bill).
 - d. Applications must be turned in by **May 1, 2017**.
3. Filing period – **March 1ST** through **May 1, 2017**.
4. How much is the Senior Sewer Discount?
 - a. **40%** discount for a Single Family Residence.
 - b. Standard Sewer Charge is **\$84.00**. Discount is **\$33.60** off.
 - c. If application is approved, 2017-2018 property tax bill will reflect the discount and the new charge will be **\$50.40**.
5. Annual filing of an application is required for the discount.
6. Application review by City (**All submitted applications will be date stamped**).
7. **Letters of Approval/Denial** will be mailed to all applicants in late **July**.

A Qualified Senior Resident, defined in the Municipal Code as a property owner who has attained the age of 62 prior to May 1, 2016, may request a discount from the City of La Puente Sewer Charge Ordinance No. 06-850 for his or her residence. This form must be filled out in full, signed, and received at the City of La Puente by **5:30 PM on MONDAY, MAY 1, 2017** to be eligible for the discount. *Please note that this discount must be requested each year.* For questions, please call (626) 855-1500.
