RESOLUTION NO. 16-5268

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA PUENTE, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON APRIL 12, 2016, DECLARING THE RESULT AND SUCH OTHER MATTERS AS MAY BE PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of La Puente, California, on Tuesday, April 12, 2016, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Election Code of the State of California, for the holding of elections in general law cities; and

WHEREAS, the Elections Official canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A". On April 18, 2016, a manual hand tally of a randomly selected precinct (Precinct 17) was conducted to ensure accuracy and consistency with the electronic ballot counter; as well as the counting of the Vote-By Mail and provisional ballots dropped off at the polls on election and the Vote-by Mail ballots postmarked by April 12, 2016 (and received in the City Clerk's office prior to 4:30 p.m. on Friday, April 15, 2016. The results of the hand tally resulted in no discrepancies being found.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA PUENTE, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

<u>Section 1</u>. That the whole number of ballots cast in the precincts except Vote-By Mail ballots and provisional ballots was 1,034. That the whole number of Vote-By Mail and provisional ballots cast in the City was 1,226. That the total number of ballots cast in the City was 2,260.

<u>Section 2</u>. That the names of persons voted for at the election for Member of the City Council were as follows: Violeta Lewis, Dan Holloway, Charlie Klinakis, John Michael Solis, Marta Samano and Leoniece Allen.

<u>Section 3</u>. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates are as listed in Exhibit "A" attached.

The City Council does declare and determine that Violeta Lewis, Dan Section 4. Holloway and John Michael Solis were elected as Members of the City Council for the full term of four years.

Section 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election showing (1) the whole number of votes cast in the City; (2) the names of the persons voted for; (3) for what office each person was voted for; (4) the number of votes given at each precinct to each person; and (5) the total number of votes given to each person.

Section 6. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated and shall cause to be administered to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the Office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

Section 7. The provisions of this Resolution are severable and if any provision, clause, sentence, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstances, such illegality, invalidity, unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, sections, words or parts thereof of the Resolution or their applicability to other persons or circumstances.

Section 8. That the City Clerk shall certify to the adoption of this Resolution and that the same shall be in full force and effect.
