



## *City of La Puente Beautification Program*

The City of La Puente's Beautification Program is available for owner-occupied, single-family applicants residing in detached dwellings within City limits. Under the program, low-income residents can participate in services that include landscape maintenance, minor exterior home repairs, removal of inoperable vehicles, clutter, and debris.

The City shall determine the eligibility and priority of all beautification work prior to award. The City reserves the right to deny requests if the application and/or the repairs do not conform to the program guidelines.

**To qualify for the Beautification Program, the annual household adjusted gross income must not exceed:**
