

RESOLUTION NO. 22-5768

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA PUENTE, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL AND SPECIAL ELECTION (CONSOLIDATED) HELD ON NOVEMBER 8, 2022, DECLARING THE RESULT AND SUCH OTHER MATTERS AS MAY BE PROVIDED BY LAW

WHEREAS, a General Municipal and Special Election (consolidated) was held and conducted in the City of La Puente, California, on Tuesday, November 8, 2022, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk's office has canvassed the returns of the election and certified the results, which were received and are attached and made a part hereof as Exhibit "A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA PUENTE HEREBY FINDS, DETERMINES AND RESOLVES AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts except vote by mail was 1,433; that the whole number of vote by mail ballots cast in the City was 4,493; making a total of 5,926 ballots cast in the City. The Los Angeles County Registrar-Recorder/County Clerk Certificate of the Canvass of the Election Returns and Statement of Votes Cast is attached hereto as Exhibit "A".

SECTION 2. That the names of persons voted for at the election for City Council Member are as follows:

Full term of 4 years

Amadeo Rodriguez
Ricardo Martinez
Valerie Munoz
Charlie Klinakis

Unexpired term ending in December 2024

John Michael Solis
Nadia Mendoza

SECTION 3. The City Council does declare and determine that Valerie Munoz and Charlie Klinakis are elected as Members of the City Council for the full term of 4 years and that Nadia Mendoza is elected as a Member of the City Council for the unexpired term ending in December 2024.

SECTION 4. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) the whole number of ballots cast in the City; (2) the names of the persons voted for; (3) for what office each person was voted for; (4) the number of votes given at each precinct to each person; and (5) the total number of votes given to each person.


SECTION 5. The City Clerk shall provide to each of the persons so elected a Certificate of Election signed by the Los Angeles County Registrar-Recorder/County Clerk and shall cause to be administered to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the Office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 6. The provisions of this Resolution are severable and if any provision, clause, sentence, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstances, such illegality, invalidity, unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, sections, words or parts thereof of the Resolution or their applicability to other persons or circumstances.

SECTION 7. That the City Clerk shall certify to the adoption of this Resolution and that the same shall be in full force and effect.
