#### BACKGROUND/DISCUSSION

The La Puente Community Foundation ("the Foundation") received 501(C)(3) exemption status from the Internal Revenue Service on April 2, 2021. This report provides the Board of Directors with a year-to-date look through July 2023 of the activity of the Foundation. Beginning July 1, 2023, City staff incorporated foundation activity into the City's accounting system to make record keeping more streamlined and easier to control.

In July 2023, the Foundation received \$71,412.87 in revenue primarily consisting of snack bar sales of \$63,571.03, donations of \$2,904.84, and field use fees of \$4,102.00. The remaining amount of \$835.00 consisted of snack bar vending donation, park vendor revenue sharing, and interest. Since this is the first month of fiscal year 2023-2024, the Foundation revenues equal the total received for the month or \$71,412.87.

On the expenses side in July 2023, the total is \$44,464.68 of which \$14,797.35 is related to snack bar expenses. \$21,32.16 of the 23,128.16 in the special events account relate to cost of supplies on the firework stand. The remainder of that account and the other account related to various operating supplies and costs related to the 3<sup>rd</sup> of July event.

The 2023-2024 fiscal year revenue is \$71,412.87 and expenses are \$44,464.68.

#### FISCAL IMPACT

The net income for fiscal year 2023-2024 is \$26,948.19.
