SUBJECT: PRESENTATION OF BUDGET REPORT FOR FISCAL 2023-2024 YEAR-TO-DATE FOR JANUARY 2024

BACKGROUND/DISCUSSION

The La Puente Community Foundation ("the Foundation") received 501(C)(3) exemption status from the Internal Revenue Service on April 2, 2021. This report provides the Board of Directors with a year-to-date look January of the activity of the Foundation. Beginning July 1, 2023, City staff incorporated foundation activity into the City's accounting system to make record keeping more streamlined and easier to control. This report will cover the month of January 2024, covering all financial activity that took place subsequent to the last Board Meeting.

In January 2024, the Foundation received \$31,165.42 in revenue primarily consisting of snack bar sales of \$14,029.97 and coffee shop sales of \$12,790.09. Field use fees also were a significant contributor at \$2,420.

On the expenses side in January 2024, the total is \$37,805.81 of which \$17,962.25 is related to snack bar and coffee shop expenses. The cost of perishable food products was high during the period due to the no-cost catering of lunch for the project LEAD students, as well as a large tournament that took place within the month. Other noteworthy expenditures in the January period include \$9,645.74 to reimburse the City of La Puente for half of the salary and benefit related expenses for the Concession and Event Supervisor for the period of October-December 2023.

FISCAL IMPACT

The net income for the fiscal year 2023-2024 is \$154,686.31

RECOMMENDATION

It is recommended that the La Puente Community Foundation receive and file this report.

BACKGROUND/DISCUSSION

The La Puente Community Foundation ("the Foundation") received 501(C)(3) exemption status from the Internal Revenue Service on April 2, 2021. This report provides the Board of Directors with a year-to-date look at the activity of the Foundation. Beginning July 1, 2023, City staff incorporated foundation activity into the City's accounting system to make record keeping more streamlined and easier to control. This report will cover the month of February 2024, covering all financial activity that took place subsequent to the last Board Meeting.

In February 2024, the Foundation received \$33,672.27 in revenue primarily consisting of snack bar sales of \$17,566.30 and coffee shop sales of \$10,652.18. Special Event Fee revenue was also a significant contributor at \$2,250. This consists of \$104.00 for the upcoming Car Show, \$1,470.00 for the Golf Classic, and \$676.00 raised for the Valentine's Day Paint and Sip event.

On the expenses side in February 2024, the total is \$9,820.95 of which \$5,629.88 is related to snack bar and coffee shop inventory purchases. Other noteworthy expenditures in the January period include \$2,753.44 in Special Event related expenses, including a deposit of \$1,000.00 for the upcoming Golf Classic.

FISCAL IMPACT

The net income for the fiscal year 2023-2024 is \$178,537.63.
