SUBJECT: PRESENTATION OF BUDGET REPORT FOR FISCAL 2024-2025 YEAR-TO-

DATE FOR AUGUST & SEPTEMBER 2025

BACKGROUND/DISCUSSION

The La Puente Community Foundation ("the Foundation") received 501(C)(3) exemption status from the Internal Revenue Service on April 2, 2021. This report provides the Board of Directors with a year-to-date look at the activity of the Foundation. Beginning July 1, 2023, City staff incorporated foundation activity into the City's accounting system to make record keeping more streamlined and easier to control. This report will cover the month of August & September 2025, covering all financial activity that took place after the last Board Meeting.

In August 2025, the Foundation received \$28,749.69 in revenue primarily consisting of snack bar sales of \$5,851.79 and LP Perk Café sales of \$15,887.05. On the Expenditure side, \$16,532.02 was spent. The majority, or \$11,395.77 was spent on snack bar and coffee shop inventory purchases. The remainder was spent on operating supplies and special event expenditures for the upcoming September events.

In September 2025, the Foundation received \$71,601.53 in revenue primarily consisting of snack bar sales of \$24,761.65 and LP Perk Café sales of \$18,733.59.

Special events were a large contributor during the September period.

- Golf Tournament (Sept. 22nd)
- Oktoberfest (Sept. 27th)

Additionally, several smaller events contributed to the bottom line for the month including for Tuesday Night Bingo weekly events, Ice Cream trailer and golf cart sales at the park. Event revenue and donations in the month of September totaled \$24,655.73.

On the expenses side in September 2025, the total is \$35,740.10. \$20,800.23 relates to putting on special events, such as the Golf Tournament and Bingo Nights. \$11,883.28 is due to snack bar and coffee shop inventory purchases.

FISCAL IMPACT

The net income for the fiscal year 2025-2026 to date is \$91,441.42.

RECOMMENDATION

It is recommended that the La Puente Community Foundation receive and file this report.
